## Introduction

An orientation workshop on Science for Women's Health and Nutrition (SFWHN) was organized by the National Council of Science and Technology Communication (NCSTC), Department of Science and Technology (DST), Government of India with the technical support of Commonwealth Educational Media Centre for Asia (CEMCA), New Delhi on April 30 and May 01, 2015 at Administrative Staff College of India, New Delhi.

National Council of Science and Technology Communication (NCSTC) DST is an apex organization under Government of India that aims to communicate science and technology, stimulate scientific temper, and to coordinate and orchestrate such efforts. The Department of Science and Technology (DST) was established in May 1971 with an objective to promote science and technology across the country.

The Orientation workshop on Science for Women's Health and Nutrition began with the registration of the participants from several Community Radio Station. A kit containing of a file folder, programme of the workshop, draft guidelines/suggestions and CEMCA's newsletter were given to the participants.

The two day session were based on the discussion of the guidelines of proposal submission to DST. The sessions were facilitated by Ms. Ujjwala T Tirkey, Scientist E, RVPSP, DST, Dr. R. Sreedher, Director, CEMCA and Ms. Rukmini Vemraju, Programme Officer, CEMCA.

Ms. Ujjwala T Tirkey, Scientist F, NCSTC, DST, in her deliberation on the initiative of the DST, said that 27 community radio stations participated actively in the DST project, i.e SFWHN and broadcast programme as specific theme that had local relevance.

She further emphasized that in the past, CEMCA has organized over 35 workshops on Community Radio and created awareness about health issues through CRS. She also lauded the efforts of "CEMCA Community Radio Facilitation Centre" which had provided excellent support for the applicants who wanted to set up CR station.

Dr. Ankuran Dutta, Programme Officer (CEMCA) presented the agenda of the programme and congratulated the NCSTC and community radio stake holders on the completion of 10 years of the project.

## Day One

Ms. Ujjwala Tirkey, Scientist 'F' of NCSTC facilitated a session and gave a brief outline of the project and enumerated the activities of the NCSTC and DST with the community radio stations of India. She praised CEMCA for initiating such programme as it brings the two under one pedestal working together for the development of community radio. Total 13 community radio representatives across India participated in the orientation workshop discussing their action plan to implement the project.

The opening session of the orientation workshop focused on draft guidelines and submission of proposal for the project. The two day sessions were based on discussions on the guidelines of the proposal to be submitted to DST. The sessions were facilitated by Ms Ujjwala Tirkey, Dr. R. Sreedher and Ms. Rukmini Vemraju, former Programme Officer of CEMCA.

During the second session on the first day Dr. Sreedher talked about the history and the present expectation on the subject 'community radio'. In his speech he said that, community radio was first acknowledged in 2002 as per the directions of the Government of India. Due to lack of financial resources/funds and sponsors, community radio in the past failed to run systematically and effectively. However, the advent of modern communication technologies in this millennium have ushered a paradigm shift on community radio. People today give more importance to community radio as it provides them the social platform to participate. Dr. Sreedher explaining about the project and asked the participants to explore their potentials in the field of CR.

The inaugural session was concluded with a brief introduction by the attendees at the workshop.

During the last session of the first day of the workshop, Ms. Tirkey, Dr. Sreedher and Ms. Vemraju explained about the financial accounting of the project, where queries from the stations regarding the management of accounts were discussed in detail. In addition Ms. Rukmini Vemraju explained about the survey methods for the baseline and content development. She emphasized the baseline study should be designed especially to undertake the survey amongst listeners. She said that to conduct a proper survey, it is wise to conduct the survey with logical conscience as not everybody can be trained and educated. Reaching the various institutions and organizations with crystal objective is the quintessential prescription for an effective survey. She explained that doing a survey only on the health of women folk is not the fitting description of this workshop and it is a 'must know' to precisely estimate and calculate the timeframe and the exact hour as to when the programme will be broadcast. She remarked about the importance of approaching the deputed medical officer from the region to understand the growing challenges of women's health. She also said that one woman can be educated and interviewed from every household as in this process the information can be disseminated and no time will be squandered.

#### **Day Two**

The second day of the session workshop began with discussions from the participants. Next session was solely devoted to discuss the action plan of the community radio stations. The project implementation issues were discussed and the radio stake holders (participants) were later facilitated by Ms. Ujjwala Tirkey and Ms. Rukmini Vemraju. Ms. Shirley Deepak made a presentation on the baseline and content development focusing on the health issues of the women folk. While rendering the presentation, Ms. Shirley Deepak laid emphasis on various ailments as several indigenous women maids suffer from ulcer as they frequently skip breakfast, while simultaneously engaging in domestic chores and manual labour. Likewise she rooted out the significance of proper observation to make note for the record regarding the

health issues of the women folk. For the surveys, weekends were chosen since the women would be working as manual labourers on the other days. Further to this talk she said that the radio broadcast was used as a prescribed policy for surveys to educate the women folks regarding the health issues and in order to properly disseminate or to conduct a survey, it is necessary to have a target audience to whom the messages will be disseminated. Ms. Jaya Chittoor, Consultant pointed out the importance of data interpretation. For effective understanding of the participants, Ms. Chittoor evaluated some objectives regarding the above subject. She laid more focus on the accounting department, systematic archive (for effective management of sources), Realizing social issues (actualization of the need of the community), analyzed whether or not it mobilized the masses – accurate planning, external evaluation, and assert never to concentrate only on one point (reason out the superstitions with science), and scientific temper.

Ms. Lalita Panwar, Hamara MSPICM, Solan and Ms. Shanta Koshti, Rudi No Radio, Ahmedabad representatives from two community radio stations shared their experiences with community radio stations and explained the methods to run the project smoothly.





Ms. Archana Kapoor of CRA and Mr. Alok Verma of M4C reiterated the importance of capacity building for self-realization and actualization. She said that the capacity building is no less important than building of one's capacity. They urged the participants to have optimum utilization of the resources provided at times when problem occurs and also reiterated the importance of capacity building of the community in absorbing information in a precise manner. Though awareness and accessibility of the resources enhance the capacity of the community, but the renovation and upgrading of the community radio stations are equally important. They also laid emphasis on the usefulness of Community Learning Programme and encouraged the participants to gain maximum benefit of the programme.

### Salient features of presentation made by CR Stations

#### The Voice of Azamgarh

The 'Voice of Azamgarh' situated in Azamgarh, Uttar Pradesh, a state of Nawabas. The team of CR expressed their willingness to join hands with the DST in concurrence with the NCSTC project and vision for science for women's health and nutrition. Voice of Azamgarh, trusting their potential prepared their project and attended the workshop organized by the NCSTC, DST in collaboration with CEMCA with an objective to spread awareness among the "Aadhi Dabadi" of their area with significant emphasis on their health. Their target group is the "weaver's women" of Sajdi, Jiyanpur, and Mubarakpur. Voice of Azamgarh cited that their board of advisory will consist of a Gynecologist, a Psychologist, Principal of a Girl College, Social Activist, and the community members of the concern community. Some of its action plans also include association with the eminent scientists, radio writers, and retired AIR personnel.

#### Alfaz-E-Mewat

'Alfaz-e-Mewat' CR is situated in Gurgaon, Haryana in NCR region. The CR envisaged targeting young mothers in Nagina and Ferozepur block of Mewat within the age group of 20-25 years who are also farm workers. They will work on issues affecting them directly such as anemia, balanced diet and nutrition, pregnancy, anti natal and post natal care, menstrual hygiene etc. The advisory committee will also approach public health foundation of India, Asha workers, CMO general hospital Mewat, local sangathan women and Dr. Chikara (nutrition expert). They thought about the regular discussion of the project with the team, meeting the advisory committee for opinions and suggestions on the project, identify every team and community women for capacity building exercise, design and plan the project and message matrix to be shared with the advisory committee.

#### **Radio Siwan**

Radio Siwan is located in a village Siwan at Bihar state. The plan of the CR is to convene regular meeting with the committee as well as with the community volunteers, inviting the NGOs operating within the periphery of the targeted areas for proper understanding of the prevailing issues, closely associate with the doctors and the Primary Health Centers (PHCs) to get their views and opinion regarding the prevailing issues, proper mapping of their coverage area and the concerned community will enhance the project. They emphasized on precise studies and experience radio Siwan has explored different views and ideas at higher level.

#### Yeralavani CR

'Yeralavani Sangli is functioning in the state of Maharashtra. The CR team expressed their views to cover villages within the radius of 10 km. A group of 10 women was proposed to form a team for focus outreach. The targeted audiences were farm working women including marginal women, destitute women, and migrant women. The subject proposed are Nutrition and hygiene, Pre and post pregnancy care, Anemia, Heat related problems, HIV/AIDs. The project advisory committee will consist of Chairperson Dr. Arvind Deshpandu, Co-Chairperson N.V. Deshpandu, Community Persons, <sup>3</sup>/<sub>4</sub> Health Experts, and 2 Community Representatives each from Asha, Anganwadi, and PC.

#### Radio Vishnu 90.4

Radio Vishu is functioning in Tamil Nadu. It has a plan to cater to a different target audience for SFWHN that will mainly include farm women, industrial women, young mothers, and house maids. Radio Vishnu 90.4 has identified 1000 women from the villages of Annavaram, Palv Koderu, and the by-pass colony. Radio Vishnu has planned to broadcast 20 minutes of new programme and 2 times repetition at different hours in a day so that the listener does not miss out on the programme and can listen to it at their convenient time. Of the 12 hour of the transmission, one hour of programme is allocated for DST project.

#### Vayalaga Vanoli

Vayalaga Vanoli CR is situated in Tamil Nadu. The target audiences of the this CR is farm women, pregnant and young mothers, and adolescent girls. During the fall of May, Vayalaga Vanoli has scheduled a basic survey and baseline surveys regarding the above cited issues. An Advisory Committee has been constituted and proposed to have their first meeting at the end of May 2015. The proposed tentative list of episodes has been given to the session panel. Before the baseline survey is executed, 25 women will be identified for baseline survey and capacity building for programme production. There will be no serious challenges on the process maintaining a data of the baseline survey as they have man resources being trained as Village Information Centre Operator. 7 Information Centre's are said to be located in the research periphery of this community radio station.

#### Radio Luit 90.8 CR

'Radio Luit 90.8' is broadcasting from Guwahati University . They said that a group of informally engaged household supporters for working couples have emerged in the recent times within the periphery of the targeted areas of Radio Luit. Substantial knowledge on health and nutrition is an earnest requirement as these women babysit or look after the children of the working couples. Secondly, a vast numbers of women listeners of Radio Luit are mostly home maker. However, most of these women possess an elementary education; they are deprived from higher education as many of them fail to read the manuals printed on the domestic articles and material. Therefore, it is necessary to disseminate information and educate these women folk focusing significantly on the issues of women's health and nutrition. Thirdly, Adolescent girls are given extra leverage while broadcasting the programme as they are exposed to many social factors that influences the very foundation of early adulthood. A girl entering the institute of marriage, even before turning 18 years of age is today considered a social hindrance. Certain factors that leave a critical impact on the girl's health such as pregnancy before 18, anemia, malnutrition etc. should be properly addressed and educated. Based on the above studies, Radio Luit has identified 1000 women in four villages of Boragoan, Garchuk, Pamohi, and North Guwahati.

Repetition of broadcasted programmes at different hours (timing) and broadcasting of new programme for 30 minutes are asserted on their action plan.

#### Lalit Lokvani CR

The CR Lalit Lokvani is in Uttar Pradesh. The representatives of the Lalit Lokvani CR remarked their action plan in brief. They said that the Orientation meeting with the NGO Directors and radio staff was encouraged and practiced. They thought of to conduct a proper baseline survey for which dedicated volunteers are selected, selection of radio production crew/team, meeting with the advisory committee is strictly recommended and convened, a systematic baseline study is implemented within the radius of 10 km of the concerned area and to meet the community or the target audience and developing a meaningful interaction regarding the health related matters is encouraged.

#### Pantnagar Janvani

'Pantnagar Janvani' the Community Radio station (90.8MHz), of Pantnagar, Uttarakhand, has been working and serving the community for more than three years and is located at the G.B. Pant University of Agriculture and Technology in Pantnagar. This CR is undertaking a project under the Science for Women's Health and Nutrition (SFWHN) through the Department of Science and Technology (DST), Government of India. For the project's implementation, 1000 rural women will be chosen as the target audience for conducting the baseline survey. These women will be selected from 100 villages surrounding the Pantnagar University, and 25 other women volunteers will be selected to conduct the survey as grass-root researchers. Participatory Rural Appraisal (PRA) methods or qualitative survey methods like Social Mapping, Resource Mapping, Matrix Ranking and more will be used along with the questionnaires to attain reliable information and with the help of this information; Participatory Community Radio Modules (PCRM) will be developed in order to produce the programmes related to women's health and nutrition.

Further an advisory committee will be formed that will include one internationally renowned scientist as the Chairman; one Communication Director as Co-Chairman; while the doctors, food and nutrition experts, health and family welfare experts, extension and communication experts, community members and others will form the rest of the committee.

#### Deccan Radio 107.8

Deccan Radio (107.8) is a CR of Hyderabad. The team of this CR decided to identify and finalize a team. Based on the community radio station's experiences, various health issues were acknowledged and different ideas need to be explored for the same.

Further, the team will be sent to the Primary Health Centers to get the doctor's views and opinion on the various issues. Also invitations will be sent out to several NGOs who have been working within the target areas. Since the coverage area and the community, has already been mapped, it will prove as an added advantage in this reference.

They expressed their views that various programme have been successfully executed with CEMCA that can further act as a bank of resourceful persons.

#### PU CR

The PU CR is located in Punjab state. Its radio programmes intend to cater to the house maids of villages aged 15-25 years and 26-40 years in Chandigarh especially in places like Dhanas, Burail and Naya Gaon among others. An advisory committee was also constituted in this regards.

Through this radio programme, the Punjab State Council for Science and Technology wants to address the various health issues and will cover anemia, TB, Malnutrition, Iodine deficiency, Bone Density studies, etc. Further it has been decided that baseline studies for the target audience i.e. 1000 maids will be done with the help of a pre-designed questionnaire.

#### Kumao Vani

Kumao vani Community Radio station is functioning from Uttarakhand. The representatives decided that a meeting should be convened with the stake holders, post which the base line surveys will be conducted and the reports will be prepared. Later these reports will be shared with the stake holders as well.

Further several group discussions will take place with the target villages. In other words, the Focus Group Discussions will be done following which the message matrix will be prepared and shared with the Expert. Once the message matrix has been prepared and shared, the episodes will be planned and recorded. After the recording, a launch event will be organized where the radio sets will be distributed. Also, different monthly field events will be planned for different villages along with regular and timely meetings for the same.

# A session on the Project implementation issues facilitated by Ujjwala T Tirkey and Ms. Rukmini Vemraju

Various issues on the implementation and preparation of the project were articulately discussed in this session. Just like every media house assembled their resources, teams, and ideas before it starts to function, radio broadcasting house follows the same pattern. Timeliness and clarity in disseminating the core objective of the programme is equally important as having trained man resources. During the midst of presentation Ms. Ujjwala T. Tirkey and Ms. Rukmini Vemraju also threw some lights on the challenges of implementing a radio house and its various essential elements on how to produce or run a community radio station.

Ms. Ujjwala T. Tirkey rendered as many as over 20 tips on implementing and preparing a programme on the Science for Women's Health and Nutrition project with special emphasis on the women's health and nutrition. Here are the tips she enlightened the audience with, on how to prepare and implement a radio programme:

- Plan well. A good beginning is always a job half done.
- Thorough preparation is necessary to recruit the required teams and also to recruit volunteers.
- Identify the local institutions.
- Constituting an advisory committee and having discussions on the ideas of the whole project with the local experts are primary contributions.
- Preparation of good promos.
- Planning of event systematically and spreading them throughout the project phase is a vital prescription.
- Publicize the project activities.
- Engagement with more stakeholders like shops, factories, markets, and clinics are recommended.
- Support the conduct of baseline survey.
- Identify the potential of a local woman and prepare to train them.
- Keeping the track of receiving sanction order from DST is mandatory. It should be practiced every month.
- Incorporate the events with media especially when hosting interpersonal or face to face events.
- The content of the programme must promote scientific temper; should be locally relevant; discourage superstitions; and contain household remedies. Local remedies can be shared when their scientific properties are precisely described.
- Prepare and maintain the scripts/synopsis and get a written approval from the experts. Also it is wise to refer with an expert for food and nutrition programme to generate authentic outputs.
